The Palestine Liberation Organization, for the benefit of the Palestinian Authority (PA), has received financing from the World Bank-International Development Association (IDA), the French Development Agency (AFD), and the European Union (EU) towards the cost of the [Hebron Regional Wastewater Management Project - Phase I]. It is intended that part of the proceeds of this grant will be applied to eligible payments under the contract for payments to a qualified Senior Environmental and Social Safeguards Expert.

The Project, which is implemented by the Palestinian Water Authority (PWA), aims to reduce the environmental pollution from wastewater produced in Hebron Municipality. The consulting services ("the Services") include:

- (i) Ensure that PWA activities on safeguards are in compliance with the World Bank's Environmental and Social requirements.
- (ii) Develop common knowledge and expertise that promote understanding and capacity building required.
- (iii) Contribute in strengthening the overall capacity of PWA and PWA Environmental and Social Compliance and Monitoring Specialist "ESCMS" in managing, overseeing, monitoring, supervising, reporting and approving the

implementation of the environmental and social safeguards measures for the World Bank's and other donors' financed projects.

The assignment is expected to commence in January 2020, and the implementation period is around two years.

The Central Tendering Department (CTD) now invites eligible Consultants to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services (TOR can be downloaded from PWA Website: www.pwa.ps).

- a) General Qualifications (Studies) (20%)
- b) Relevant and Specific Experience (80%)
