**Project Name**: Technical Assistance to the Project Coordination Unit for Implementation of the Rolling Program of Interventions for Additional Supply of Water for the Gaza Strip (TA-G-PCU-phase 2)

**Assignment Name**: Revision of the existing Sewage Master Plan for the Khanyounis Governorate and Detailed Design of the sewage collection system in the Eastern Villages.

- 1. The Palestinian Water Authority (PWA) has received financing from the Austrian Development Agency (ADA), under the project "Technical Assistance to the Project Coordination Unit for Implementation of the Rolling Program of Interventions for Additional Supply of Water for the Gaza Strip" (TA-G-PCU phase 2). The PWA, through the Gaza Project Coordination Unit (G-PCU) intends to apply part of the funds for consulting services to review Sewage/ Wastewater Master Plan for the Khanyounis Governorate and develop detail design for the sewage collection system in the eastern villages.

The PWA, now invites eligible consulting firms having relevant experience to perform the service to collect the request for proposal documents starting from August 25, 2021 during the working hours between 9:00 am to 2:00pm from central tendering department as mentioned in the <u>address 2</u> below and upon the payment of a non-refundable fee of 200 NIS (Two hundred sheqels). - 4. Bids shall be valid for a period of 120 days from the date of tender opening, and must be accompanied by bid security of one thousand, five hundreds (1,500) EURO or Equivalent valid for a period of 150 days from the date of opening tenders.
- 5. A firm will be selected under Quality and Cost Based Selection (QCBS) method.
