The Consulting firm should have experience in implementing at least 3 assignments during the last 5 years that have been successfully and substantially completed, involving the development of similar assessments to existing warehouse and inventory systems.

The Qualifications and Experience of Key Experts shall not be included in the short-listing criteria].

Key Experts will not be evaluated at the short-listing stage.

The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank's "Procurement Regulations for IPF Borrowers" July 2016 revised 2017.

Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a sub-

consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.
